- 1) The brand or make of the item should be specifically stated and complete set of specifications and dimensions should be given. Preference would be given to internationally recognized brand. Brochure of the item should be provided with the quotation.
- 2) If asked, samples must be accompanied with the quotations
- 3) Price should be inclusive of all Sales tax, General tax, Central Sales tax, Custom duty, Insurance charges, Packing and Forwarding charges.
- 4) This Institute is located within the limits of S.M.C. & exempted from the paying of octroi duty on incoming goods from outside limits of S.M.C.
- 5) This Institute is registered with the dept. of scientific & industrial Research (DSIR) for the purpose of availing custom duty exemption & central excise duty exemption, and hence the certificate to this effect will be issued wherever it is necessary on demand.
- 6) The period of validity of the quotation should be at least 45 Days. Offers subject to prior sale may please be avoided. The delivery period is to be clearly mentioned in the quotation.
